

## JOINT TRAC/ISTAC CONFERENCE

Iran and Turkey, two regional giants with fastest growing economies and great historical heritages, each host today an arbitral institution that offers legal and cultural safeguards for cost effective means of international dispute resolution.

Iran hosts in Tehran the Tehran Regional Arbitration Centre (TRAC), an independent international organization under the auspice of the Asian-African Legal Consultative Organization (AALCO) that was established pursuant to an agreement signed on 3 May 1997 between the Islamic Republic of Iran and ALLCO. This agreement came into force in July 2004, and TRAC effectively commenced its activities a year later and published its Rules of Arbitration in July 2005, which are inspired from the UNCITRAL Arbitration Rules.

Turkey hosts in Istanbul the Istanbul Arbitration Centre (ISTAC), an independent institution established upon governmental initiative, under law No. 6570 of November 29, 2014, that commenced its activities in the third quarter of 2015. The General Assembly of ISTAC unanimously approved the ISTAC Arbitration Rules on October 26, 2015, largely inspired from the ICC Arbitration Rules, which became effective immediately.

Both institutions have the full support of their host States at the highest level to ensure their independence and their respective promotion for use by the public and private sectors of the country as well as by foreigners for the resolution of international disputes, whether involving their respective host State, other States in the region, or operators thereof.

TRAC and ISTAC have decided to engage in joint efforts by way of yearly conferences in Paris, Istanbul, and Teheran, to introduce their rules and operations, to set out their distinguishing features, and to explain why the public and private operators of the two countries will be increasingly proposing both of these two institutions to foreign parties as alternatives to other regional and international institutions for the resolution of international disputes in the interest of all parties involved while candidly addressing any questions or concerns that users may have.

The first conference will be held in Paris on December 12, 2016 in Paris, the second and third in Teheran and Istanbul in 2017, hosted by TRAC and ISTAC in cooperation with Derains & Gharavi. These conferences, by invitation only limited to 60 guests, will gather in-house counsels, contract and arbitration counsel, academics and arbitrators as well as representatives from each government in charge of the State arbitrations.
